

City Church Dublin Child Safeguarding Statement

City Church Dublin operates under the auspices of Irish Church Missions, an Anglican mission organisation aligned with the Church of Ireland.

City Church provides religious, educational and recreational activities and services to children under 18 years of age through its local churches.

City Church acknowledges its duty of care to safeguard and promote the welfare of children and is committed to ensuring safeguarding practice that reflects statutory responsibilities, government guidance and complies with best practice.

City Church is committed to safeguarding children by working under the guidance of the Church of Ireland's national safeguarding policy *Safeguarding Trust* and its associated procedures. City Church recognises that the welfare and interests of children are paramount in all circumstances. The church elders, staff and volunteers are committed to ensuring that all children have a positive experience in a safe and child centred environment and are protected from abuse whilst participating in activities.

City Church has conducted a specific written risk assessment of any potential for harm to a child through their involvement in church activities. The written risk assessment indicates the areas of potential harm, the likelihood of harm occurring, and lists the required policy, guidance, process and practice required to alleviate the risks. Site specific risks, which are in addition to those listed below, have also been documented.

- Procedures for reporting child protection and welfare concerns to Túsla and An Garda Síochána.
- Procedures for maintaining a list of persons in each church who are mandated persons.
- Procedure for appointing a relevant person for this child safeguarding statement.
